

AN ORDINANCE PROVIDING FOR THE COUNCIL OF THE CITY OF CORTLAND, OHIO TO APPROPRIATE FUNDS FOR THE OPERATION OF THE VARIOUS FUNDS OF THE CITY OF CORTLAND, OHIO AND ITS POLITICAL SUBDIVISIONS AND DECLARING AN EMERGENCY

WHEREAS, all of the political subdivisions have not submitted budget requests for the current year of operation and therefore, the Annual Appropriation Ordinance is pending.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$50,000 for the operation of the General Fund (General, Service, Safety) until passage of the Annual Appropriation Ordinance.

Section 2. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$150,000 for the operation of the Policy Levy Fund until passage of the Annual Appropriation Ordinance.

Section 3. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$75,000 for the operation of the M&R Fund until passage of the Annual Appropriation Ordinance.

Section 4. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$5,000 for the operation of the State Highway Fund until passage of the Annual Appropriation Ordinance.

Section 5. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$10,000 for the operation of the \$5.00 Auto (Permissive Tax) until passage of the Annual Appropriation Ordinance.

Section 6 That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$3,000 for the operation of the New Customer Service Fund until passage of the Annual Appropriation Ordinance.

Section 7. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$150,000 for the operation of the Water Revenue Fund until passage of the Annual Appropriation Ordinance.

Section 8. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$120,000 for the operation of the Sewer Revenue Fund until passage of the Annual Appropriation Ordinance.

Section 9. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$10,000 for the operation of the 90% Sewer Improvement Fund until passage of the Annual Appropriation Ordinance.

Section 10. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$120,000 for the operation of the Fire Levy Fund until passage of the Annual Appropriation Ordinance.

Section 11. That the Council of the City of Cortland, be and is hereby authorized to appropriate \$5,000 for the operation of the Continuing Education Fund until passage of the Annual Appropriation Ordinance.

Section 12. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$30,000 for the operation of the Fire Improvement Fund until passage of the Annual Appropriation Ordinance.

Section 13. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$50,000 for the operation of the CHIP Grant Fund until passage of the Annual Appropriation Ordinance.
