AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER AN AGREEMENT WITH THOMAS FOK AND ASSOCIATES, INC. TO PERFORM DETAILED DESIGN AND CONSTRUCTION ADMINISTRATION/INSPECTION FOR THE DOWNTOWN WATERLINE REPLACEMENT PROJECT- PHASE III

WHEREAS, on December 15, 2014, Council passed Ordinance O-75-14 authorizing the City to submit a loan application to participate in the Ohio Public Works Commission (OPWC) State Capital Improvement Program for the Downtown Waterline Replacement - Phase III; and,

WHEREAS, Council authorized the payment of an interest free twenty (20) year loan in the amount of \$366,250.00 under OPWC; and,

WHEREAS, the cost of the detailed design and construction administration/inspection services will be included in the loan obligation through OPWC; and,

WHEREAS, Thomas Fok and Associates, Inc. has provided a proposal to perform detailed design and construction administration/inspection; and,

WHEREAS, the cost of \$58,600 for services will be paid through OPWC and \$2,799 for additional sidewalk design will be the city's share.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Cortland City Council authorizes the Mayor to enter an agreement with Thomas Fok and Associates, Inc. 3896 Mahoning Ave. Youngstown, Ohio 44515 to perform detailed design and construction administration/inspection for the Downtown Waterline Replacement - Phase III.

Section 2. That Council hereby authorizes payment for services at a total cost not to exceed \$2,799 if authorized to be paid from Fund 10-J-234 - General - Service Dept. Op - Professional Services.

Section 3. This Ordinance shall take effect and be in full force as early as allowed by law.
