AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER AN AGREEMENT WITH GPD GROUP TO PERFORM DETAILED DESIGN SERVICES FOR THE LAKEVIEW SCHOOLS PEDESTRIAN ENHANCEMENT - PHASE II

WHEREAS, the Council of the City of Cortland, through R-09-14, supported the submission of an application for the Transportation Alternatives Program (TAP); and,

WHEREAS, the City of Cortland has received funding approval for the Lakeview Schools Pedestrian Enhancement –Phase II which will provide 80% of the construction and inspection costs with the City providing a minimum of 20% cash contributions; and,

WHEREAS, the City requested GPD Group to provide a cost proposal for the services; and,

WHEREAS, the consultant has provided a detailed technical and cost proposal for the design services; and,

WHEREAS, the City is responsible for 100% of the detailed engineering cost which totals \$26,000 for basic services and \$17,420 for environmental services if authorized.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Cortland City Council authorizes the Mayor to enter an agreement with GPD Group, 520 South Main St., Suite 2531, Akron, Ohio 44311 to perform detailed services for the Lakeview Schools Pedestrian Enhancement Project – Phase II.

Section 2. That Council hereby authorizes payment for the basic services at a cost not to exceed \$ 26,000 to be paid from Fund 15-P-251 –Parks & Recreation – Capital Improvement.

Section 2. That Council hereby authorizes the payment for the environmental services at a cost not to exceed \$17,420 if required to be paid from Fund 15-P-251 – Parks & Recreation - Capital Improvement.

Section 4. This Ordinance shall take effect and be in full force as early as allowed by law.
