**AN ORDINANCE AUTHORIZING THE FIRE CHIEF TO ENTER INTO AN AGREEMENT WITH GRUNDER CONTRACTING AND TILE TO REMODEL RESTROOM FACILITIES AT THE CORTLAND CITY FIRE STATION**

**WHEREAS**, there is a need to remodel the shower and men’s restroom facility at the Cortland City Fire Station; and,

**WHEREAS**, after soliciting quotes from three contractors, the City Fire Department received one cost estimate prepared by Grunder Contracting and Tile in the amount of \$9,349.50; and,

**WHEREAS**, the Cortland Fire Chief has reviewed and approved the proposal from Grunder Contracting and Tile.

**NOW, THEREFORE:**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:**

**Section 1.** That the Council of the City of Cortland does hereby authorize the Fire Chief to enter into an agreement with Grunder Contracting and Tile, 3187 McMullen Allen Rd, Newton Falls, OH 44444 to remodel restroom facilities at the Cortland City Fire Station.

**Section 2.** The remodel of restroom facilities will include the following improvements:

Shower	\$4,531.50
Men’s Restroom	\$4,818.00

**Section 3.** The total cost of the remodel not to exceed \$9,349.50 will be paid out of the following funds:

\$2,500.00	Fund 92-M-234	Continuing Education – Professional Services
\$6,849.50	Fund 95-L-234	Fire Levy Fund – Building & Grounds – Prof Services

**Section 4.** This Ordinance shall take effect and be in full force as early as allowed by law.
