

AN ORDINANCE AMENDING THE ANNUAL APPROPRIATION ORDINANCE O-38-15 FOR THE CITY OF CORTLAND, COUNTY OF TRUMBULL, STATE OF OHIO, FOR FISCAL YEAR ENDING ON THE 31<sup>ST</sup> DAY OF DECEMBER 2015 AND DECLARING AN EMERGENCY
