

A RESOLUTION AUTHORIZING THE FIRE DEPARTMENT TO PROVIDE EDUCATIONAL SERVICES TO PARAMEDICS, EMS CREWS AND FIREFIGHTERS OUTSIDE THE CITY AND TO CHARGE A FEE FOR SUCH SERVICES

WHEREAS, the City of Cortland Fire Department provides educational services to employees within its department and to men and women from departments outside the City for continuing education and for certification purposes; and,

WHEREAS, the Council of the City of Cortland supports this endeavor and believes it enhances the City of Cortland's Fire Department and EMS crews; and

WHEREAS, the Council of the City of Cortland, through this legislation, will authorize its Fire Department to offer these classes and to charge a reasonable fee for these classes.

NOW, THEREFORE:

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO THAT:

Section 1. The Cortland Fire Department is authorized to provide educational services to firefighters, paramedics and EMS personnel from inside the City as well as Fire/EMS/Paramedic personnel from outside the City.

Section 2: The following classes will be provided at the corresponding fee:
