

A RESOLUTION ACCEPTING THE AMOUNT AND RATES AS DETERMINED BY THE BUDGET COMMISSION OF TRUMBULL COUNTY AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR

WHEREAS, the Council of the City of Cortland, Trumbull County, Ohio, met in regular session on the 8th day of September, 2015 at the Cortland Administration Building, Council Chambers with the following council members present:

Councilman Piros, moved the adoption of the following Resolution:

WHEREAS, this Council, in accordance with the provisions of Ohio Revised Code Section 5705.281 previously provided to the Budget Commission of Trumbull County the Alternative Tax Budget Information for the next succeeding fiscal year commencing January 1, 2016; and,

WHEREAS, the Budget Commission of Trumbull County, Ohio, has certified its action thereon to this Council together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council, and what part thereof is without, and what part within the ten mill tax limitations.

NOW, THEREFORE:

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the amounts and rates, as determined by the Budget Commission in its certification, be and the same are hereby accepted.

Section 2. That there be and is hereby levied on the tax duplicate the rate of each tax necessary to be levied within and without the ten mill limitation as follows:
