AN ORDINANCE AUTHORIZING THE CITY OF CORTLAND TO ENTER INTO A CONTRACT WITH KARVO COMPANIES INC FOR THE 2016 RESURFACING PROGRAM AND DECLARING AN EMERGENCY

WHEREAS, the City of Cortland has identified the need to resurface certain streets for the 2016 Asphalt Resurfacing Program and include the following roadways:

**Lakeview Dr (Portal Dr to Wakefield Dr)
Fowler St (Maplewood Dr to eastern city limits)
Diamond Way (Fowler St to Gemwae)
Gemwae**

WHEREAS, the city applied to participate in the Ohio Public Works Commission (OPWC) State Capital Improvement and/or Local Transportation Improvement Program and has obtained an OPWC grant to pay 39% of the project cost up to \$74,999.00; and,

WHEREAS, the Clerk of Council has advertised for bids in accordance with said authorization; and,

WHEREAS, on the 15th day of June, 2016, bids were publically opened and Karvo Companies Inc was the lowest and best bidder in the amount of \$171,860.00.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Council of the City of Cortland does hereby authorize the Mayor of the City of Cortland, Ohio to enter into a contract with Karvo Companies Inc, 4524 Hudson Dr, Stow, OH 44224 for the 2016 Resurfacing Program.

Section 2. The local share of the project is \$104, 834.60 which will come out of the following funds:

\$ 4,834.60	10-J-234	General Fund – Professional Services
\$ 65,000.00	40-J-234	M & R Fund - Professional Services
\$ 35,000.00	46-J-234	Permissive Tax Fund – Professional Services

Section 3. The Finance Director of the City of Cortland shall be authorized to make payment to Karvo Companies Inc, upon completion of said project and upon having approval of the Service Director that said work is done according to specifications as set forth by the City of Cortland.

Section 4. This Ordinance having the procedural rules suspended shall take effect immediately as being necessary to expedite the roadway project and protect the health, safety and welfare of the residents of the City of Cortland, Ohio.
