**AN ORDINANCE WHEREBY THE CITY OF CORTLAND
AUTHORIZES FUNDING TO YNG AIR PARTNERS TO
SUPPORT ITS SERVICES FOR DAILY FLIGHTS IN AND OUT
OF THE YOUNGSTOWN-WARREN REGIONAL AIRPORT**

WHEREAS, on May 5, 2014, the City of Cortland passed Resolution R-21-14 pledging support to YNG Air Partners in its efforts to secure daily flights in and out of the Youngstown-Warren Regional Airport; and,

WHEREAS, the citizens of the City of Cortland have in the past, and there is a very strong likelihood that they will in the future, utilize daily flights on a commercial air carrier in and out of the Youngstown-Warren Regional Airport in Vienna Township; and,

WHEREAS, Cortland has been identified as a city contained in the “catchment area” from which comes usage of the Youngstown-Warren Regional Airport and the City has been identified as representing 1.10% of the total catchment area; and,

WHEREAS, the YNG Air Partners is a non-profit, 501(c)(3), local agency which is gathering local match money in order to support a daily commercial air carrier at the Youngstown-Warren Regional Airport; and,

WHEREAS, the Youngstown Regional Airport has secured the commercial air carrier, Aerodynamics Incorporated as the provider of flights to and from Chicago O’Hare International Airport; and,

WHEREAS, YNG Air Partners is now requesting the City of Cortland pay the sum of \$5,500.00 which represents Cortland’s percentage representation in the catchment area; and,

WHEREAS, these funds are needed to match a U.S. Department of Transportation grant and to match private contributions in support of the commitment from Aerodynamics Incorporated to conduct daily air service at the Youngstown-Warren Regional Airport.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Council of the City of Cortland authorizes a one time payment in the amount of \$5,500.00 as the City’s local contribution to YNG Air Partners in support of daily flights in and out of the Youngstown-Warren Regional Airport.

Section 2. The contribution authorized herein will be paid out of Fund 10-X-239 General – General Other - Misc.

Section 3. This Ordinance shall take effect and be in full force as early as allowed by law.
