

AN ORDINANCE AUTHORIZING THE CITY OF CORTLAND TO ACCEPT A PROPOSAL FROM THE OHIO FIRE CHIEFS' ASSOCIATION TO PERFORM TESTING SERVICES TO AID IN THE FILLING OF ITS VACANT FIRE CAPTAIN POSITION AND DECLARING AN EMERGENCY

WHEREAS, Fire Captain AC McMillion retired from the City of Cortland effective August 6, 2016; and,

WHEREAS, there is now a vacancy in the Fire Captain position and the City of Cortland has begun its process to appoint a new Fire Captain; and,

WHEREAS, the City's Civil Service Commission met on August 18, 2016 and recommended using a hiring process that involves both a written test in the form of a Captain Examination and a three (3) person Oral Interview Board.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the City of Cortland accepts the recommendation of its Civil Service Commission to utilize both a written Captain Examination as well as a three (3) person Oral Interview Board at a total cost not to exceed \$4,500.00.

Section 2. That in order to implement this procedure the Cortland City Council authorizes the acceptance of the proposal from the Ohio Fire Chiefs' Association, 450 West Wilson Bridge Rd, Suite 150, Worthington, OH 43085 to perform both a written test in the form of a Captain Examination and a three (3) person Oral Interview Board.

Section 3. That Council hereby authorizes payment for these services at a total cost not to exceed \$4,500.00 to be paid from Fund 10-X-232 - General – Other – Civil Service Commission.
