

**A RESOLUTION PROVIDING FOR THE COUNCIL OF THE CITY OF CORTLAND TO INDICATE WHAT SERVICES, IF ANY, THE CITY WILL PROVIDE TO THE OWNERS OF REAL ESTATE CONTAINING 1.236 ACRES PROPOSED FOR ANNEXATION FROM BAZETTA TOWNSHIP TO THE CITY OF CORTLAND, OHIO**

**WHEREAS**, the City of Cortland has received "Notice of Petition For Annexation" filed with the Board of County Commissioners of Trumbull County, Ohio, on the 12th day of January, 2016, which petition was signed by Ben F. Duncan and Evelyn K. Duncan, as owners of real estate residing in the territory, and further praying that the territory described therein be annexed to the City of Cortland in the manner provided by law, a copy of said petition attached hereto and made a part hereof; and,

**WHEREAS**, this is a Type 2 Annexation pursuant to O.R.C. 709.023; and,

**WHEREAS**, the City of Cortland makes available to its residents sewer and water services; and,

**WHEREAS**, pursuant to Resolution R-49-80, passed September 22, 1980, property owners seeking annexation must be prepared to pay for extension of sewer and water lines and construction of streets to specification; and,

**WHEREAS**, the City of Cortland welcomes the annexation to the City of Cortland any adjacent territory whose owner seek annexation for the purpose of securing City services.

**NOW, THEREFORE:**

**BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CORTLAND:**

**Section 1.** The City of Cortland, Ohio will make its sewer and water services available to the owners of real estate residing in the territory which is the subject of an annexation petition filed with the Trumbull County Commissioners on the 12th day of January, 2016, praying that said territory be annexed in the manner provided by law, a copy of which notice is attached hereto and made a part of hereof.

**Section 2.** The owners of the real estate must be prepared to pay for the extension of these services to their territory.

**Section 3.** This Resolution shall take effect and be in full force as early as allowed by law.
