

A RESOLUTION AUTHORIZING THE MAYOR TO PLACE HIS SIGNATURE ON AN AGREEMENT FOR CONNECTION TO THE CITY OF CORTLAND WATER DISTRIBUTION SYSTEM

WHEREAS, The City of Cortland owns and operates its own municipal water distribution system; and,

WHEREAS, Diana K. Ashdown owns a residential duplex in Bazetta Township whose address is 3413 Niles-Cortland Road and whose permanent parcel identification number is 33-004501; and,

WHEREAS, Diane K. Ashdown’s residential duplex is already connected to the sanitary sewer system pursuant to an agreement between the City of Cortland and the Trumbull County Commissioners dated April 5, 1988, and she has now requested a water tapping permit to the City’s water distribution system; and,

WHEREAS, the Owner needs to connect the property to the City’s water distribution system to keep the premises habitable and the City is agreeable to the tap-in so long as the property owner pursues traditional annexation of the property; and

WHEREAS, the parties acknowledge that exigent circumstances exist which require an expedited tap-in to the City water line to allow habitable living conditions to continue uninterrupted; and,

WHEREAS, Council agrees that the Mayor may enter an agreement allowing for this connection to the City of Cortland water distribution system the terms of which are acknowledged herein; and,

WHEREAS, the City agrees to issue a water tap-in as if the parcel was located in the City contingent on the approval of the Trumbull County Sanitation Engineer and subject to all current rules, regulations and specification of the City of Cortland and Trumbull County Sanitary Engineer; and,

WHEREAS, the Owner agrees to immediately pursue traditional annexation to the City of Cortland.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Council of the City of Cortland does hereby authorize the Mayor to place his signature on the agreement for connection to the City of Cortland water distribution system.

Section 2. That the Council of the City of Cortland does hereby authorize the Service Director to issue a Water Tapping Permit to the residential duplex at 3413 Niles-Cortland Road subject to all current rules, regulations and specification of the City of Cortland and the Trumbull County Sanitary Engineer.

Section 3. That this Resolution shall take effect and be in full force from and after the earliest period allowed by law.
