AN ORDINANCE AUTHORIZING THE POLICE CHIEF TO PURCHASE ACCESSORIES AND INSTALLATION OF THE ACCESSORIES IN THE 2018 FORD POLICE INTERCEPTOR SPORT UTILITY VEHICLE

WHEREAS, the Council of the City of Cortland, through the passage of Ordinance O-48-17, approved the purchase of a 2018 Ford Police Interceptor Sport Utility Vehicle to be utilized as a police cruiser; and,
