AN ORDINANCE AUTHORIZING THE MAYOR TO SIGN AN INTERGOVERNMENTAL AGREEMENT FOR THE CITY OF CORTLAND TO PARTICIPATE IN AND PARTIALLY FUND THE TRUMBULL COUNTY TRANSIT SERVICE

WHEREAS, the City of Cortland pursuant to Resolution R-36-01 authorized its support for a county-wide public transit service; and

WHEREAS, the Trumbull County Transit Board was formed by the Trumbull County Board of Commissioners in 2011 to provide public transportation in Trumbull County; and

WHEREAS, the Trumbull County Transit Board is the designated sub-recipient of federal transit funding in Trumbull County; and

WHEREAS, the Trumbull County Transit Board is seeking intergovernmental agreements from its municipal partners to fund local contributions on an annual basis; and

WHEREAS, in exchange for the City’s funding, Cortland residents will receive a 50% discount on the normal TCT fare, while Cortland senior residents over the age of 60 will be charged a rate that is 25% lower than that charged to other seniors throughout Trumbull County.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. The Council of the City of Cortland supports funding to the Trumbull County Transit Board in an amount equal to fifty cents (\$0.50) per Cortland citizen, based upon the 2010 U.S. Census, as the City’s local contribution for matching federal transit dollars and operating the demand response public transit service that meets the needs of the City’s residents.

Section 2. The Mayor is authorized to sign and implement on behalf of the City the Intergovernmental Agreement with the Trumbull County Transit Board.

Section 3. The amount not to exceed \$3,552.00 represents the City’s 2018 contribution and subsequent annual payments to be made in the amount determined under Section 1 will be taken from Fund 1000-790-399 - General – Administrative – Misc.

Section 4. This Ordinance shall take effect and be in full force from as early as allowed by law.
