AN ORDINANCE AUTHORIZING THE POLICE CHIEF TO PURCHASE AND INSTALL A MOBILE RECORDS SOFTWARE SYSTEM FOR THE CORTLAND CITY POLICE DEPARTMENT

WHEREAS, the Council of the City of Cortland recognizes the benefit to its Police Department to purchase and install a mobile records software system in each City police cruiser; and,

WHEREAS, the Police Chief reviewed and approved a quote from ID Networks, Inc. to purchase and install a mobile records software system in each of the police cruisers to include an initial one (1) year maintenance cost not to exceed \$3,000.00 with subsequent annual maintenance fees of \$540.00; and,

WHEREAS, the Police Chief also reviewed and approved a quote from ABC Dimensions, Inc to install the mobile records software system at the police station at a price not to exceed \$2,000.00.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Council of the City of Cortland does hereby authorize the Police Chief to purchase and install the mobile records software system from ID Networks, Inc., 7720 Jefferson Rd, Ashtabula, OH 44004 at a cost of \$ 3,000.00, which includes the first year maintenance fee.

Section 2. That the Council of the City of Cortland does hereby authorize the Police Chief to arrange for the installation of the records system at the police station by ABC Dimensions, Inc., 975 Tibbetts-Wick Rd, Girard, OH 44420 at a cost of \$ 2,000.00.

Section 3. The total first year cost shall not exceed \$ 5,000.00 and said cost will be paid from the following funds:

\$3,000.00	Fund# 2901-110-394 (Police - Machinery, Equipment, & Furniture)
\$2,000.00	Fund# 2901-110-300 (Police – Contractual Services)

Section 4. Subsequent annual maintenance payments of \$540.00 to ID Networks, Inc. will be paid from Fund 2901-110-300 (Police - Contractual Services).

Section 5. This Ordinance shall take effect and be in full force as early as allowed by law.
