

AN ORDINANCE AMENDING THE ANNUAL APPROPRIATION ORDINANCE O-09-18 FOR THE CITY OF CORTLAND, COUNTY OF TRUMBULL, STATE OF OHIO, FOR FISCAL YEAR ENDING ON THE 31ST DAY OF DECEMBER 2018 AND DECLARING AN EMERGENCY
