

**AN ORDINANCE AUTHORIZING THE FIRE CHIEF TO PURCHASE HOODS AND GLOVES FOR THE FIRE DEPARTMENT FROM FINLEY FIRE EQUIPMENT AND DECLARING AN EMERGENCY**

**WHEREAS**, it is necessary for the Fire Department to purchase hoods and gloves to protect the firefighters; and

**WHEREAS**, the Fire Chief has reviewed and obtained a quote from Finley Fire Equipment for hoods and gloves for the City Fire Department not to exceed \$9,818.00; and

**WHEREAS**, the Fire Chief then submitted this quote to the Ohio Bureau of Workers' Compensation which approved the same; and

**WHEREAS**, the Fire Department received an Ohio Bureau of Workers' Compensation Grant in the amount of \$8,181.66 to be used toward this purchase with the City's local share of \$1,636.34.

**NOW, THEREFORE:**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:**

**Section 1.** That the Council of the City of Cortland does hereby recognize the need for hoods and gloves for the Fire Department.

**Section 2.** That the Council of the City of Cortland does hereby authorize the Fire Chief to purchase hoods and gloves from Finley Fire Equipment, 5255 N SR60 NW, McConnelsville, OH 43756 for a total cost not to exceed \$9,818.00.

**Section 3.** The sum of \$9,818.00 will be paid out of City Fund 2902-120-394 (Fire Levy, Fire Fighting, Prevention & Inspection, New Equipment) with \$8,181.66 being paid to the City through an Ohio Bureau of Workers' Compensation Grant.

**Section 4.** This Ordinance having the procedural rules suspended shall take effect immediately as being in the best interest of the public health, safety and welfare of the residents of the City of Cortland, Ohio insofar as securing the best available price that will expire before three readings.
