

**AN ORDINANCE APPROVING THE EDITING AND INCLUSION OF CERTAIN ORDINANCES AS PARTS OF THE VARIOUS COMPONENT CODES OF THE CODIFIED ORDINANCES OF CORTLAND, OHIO AND TO AMEND OR ENACT SECTIONS OF THE TRAFFIC AND GENERAL OFFENSES CODES TO CONFORM TO ENACTMENTS OF THE GENERAL ASSEMBLY AND DECLARING AN EMERGENCY AS NOT TO DISRUPT THE SERVICES FOR CONTINUED OPERATION OF THE AFFECTED DEPARTMENTS**

**WHEREAS**, various ordinances of a general and permanent nature have been passed which should be included in the Codified Ordinances of the City of Cortland, Ohio; and

**WHEREAS**, numerous sections in the Traffic and General Offenses Codes need to be updated in order to bring them into compliance with amendments enacted by the General Assembly; and

**WHEREAS**, Section 3.13 of the City Charter provides for the codification of City ordinances and the City has entered into a contract with the Walter H. Drane Company to prepare and publish such codification.

**NOW, THEREFORE:**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:**

**Section 1.** That the editing, arrangement and numbering or renumbering of those ordinances and parts of ordinances of a general and permanent nature are hereby approved as parts of the various component codes of the Codified Ordinances of Cortland, Ohio, so as to conform to the classification and numbering system of the Codified Ordinances.

**Section 2.** The following sections of the Traffic and General Offenses Codes, as amended, are hereby approved and adopted as amended or enacted so as to conform to enactments of the Ohio General Assembly:

- 333.01      Driving Under the Influence. (Amended)**
- 337.28      Use of Sunscreening, Nontransparent and Reflectorized Materials. (Amended)**

**GENERAL OFFENSES CODE**

- 513.09      Controlled Substance or Prescription Labels. (Amended)**
- 529.07      Open Container Prohibited. (Amended)**
- 529.08      Hours of Sale or Consumption. (Amended)**
- 537.15      Temporary Protection Order. (Amended)**

**BUILDING CODE**

- Ch. 1301    Ohio Building Code. (Amended)**

**Section 3.** A copy of such ordinances or parts of ordinances as edited, arranged and numbered or renumbered as parts of the Codified Ordinances is attached to this ordinance in the form of 2018 Replacement Pages to the Codified Ordinances.

**Section 4.** That this Ordinance upon having the procedural rules suspended shall take effect immediately as being in the best interest of the public health, safety and welfare of the residents of the City of Cortland and further it is necessary for the continued operation of the affected departments.
