

AN ORDINANCE PROVIDING FOR THE COUNCIL OF THE CITY OF CORTLAND, OHIO TO APPROPRIATE FUNDS FOR THE OPERATION OF THE VARIOUS FUNDS OF THE CITY OF CORTLAND, OHIO AND ITS POLITICAL SUBDIVISIONS FOR 2019 AND DECLARING AN EMERGENCY

WHEREAS, all of the political subdivisions have not submitted budget requests for the 2019 year of operation and therefore, the Annual Appropriation Ordinance is pending.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$225,000 for the operation of the General Fund #1000 until passage of the Annual Appropriation Ordinance.

Section 2. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$403,275 for the operation of the Policy Levy Fund #2901 until passage of the Annual Appropriation Ordinance.

Section 3. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$105,000 for the operation of the Street Construction, Maintenance Repair Fund #2011 until passage of the Annual Appropriation Ordinance.

Section 4. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$15,000 for the operation of the State Highway Fund #2021 until passage of the Annual Appropriation Ordinance.

Section 5. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$50,000 for the operation of the Permissive Motor Vehicle License Tax Fund #2101 until passage of the Annual Appropriation Ordinance.

Section 6. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$6,000 for the operation of the New Customer Service Fund #5201 until passage of the Annual Appropriation Ordinance.

Section 7. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$385,000 for the operation of the Water Operating Fund #5101 until passage of the Annual Appropriation Ordinance.

Section 8. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$265,000 for the operation of the Sewer Operating Fund #5202 until passage of the Annual Appropriation Ordinance.

Section 9. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$10,000 for the operation of the Sewer Tap Reserve Fund #5702 until passage of the Annual Appropriation Ordinance.

Section 10. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$300,000 for the operation of the Fire Levy Fund #2902 until passage of the Annual Appropriation Ordinance.

Section 11. That the Council of the City of Cortland, be and is hereby authorized to appropriate \$10,000 for the operation of the Continuing Education Fund #5601 until passage of the Annual Appropriation Ordinance.

Section 12. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$30,000 for the operation of the Fire Improvement Fund #2903 until passage of the Annual Appropriation Ordinance.

Section 13. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$1,000 for the operation of the Drug Trust Fund #2081 until passage of the Annual Appropriation Ordinance.

Section 14. That the Council of the City of Cortland, be and is hereby authorized to appropriate the sum of \$1,000 for the operation of the Law Enforcement & Education Fund #2082 until passage of the Annual Appropriation Ordinance.

Section 15. This Ordinance upon having the procedural rules suspended shall take effect immediately as being in the best interest of the public health, safety and welfare of the residents of the City of Cortland and further it is necessary for the continued operation of the affected departments.
