

**A RESOLUTION AUTHORIZING THE CLERK OF COUNCIL OF THE CITY OF CORTLAND TO ADVERTISE FOR BIDS FOR THE 2018 ASPHALT RESURFACING PROGRAM**

**WHEREAS**, the City of Cortland has identified the need to resurface certain streets in 2018; and,

**WHEREAS**, the roadways for the 2018 Asphalt Resurfacing Program have been finalized and reviewed by the Technical Review Committee and include the resurfacing of the following streets:
