

A RESOLUTION PROVIDING FOR THE COUNCIL OF THE CITY OF CORTLAND, OHIO TO ACCEPT THE ANNEXATION OF TERRITORY FROM BAZETTA TOWNSHIP TO THE CITY OF CORTLAND, OHIO CONTAINING 0.8970 ACRES OF LAND

WHEREAS, on March 19, 2018, Council passed Resolution R-12-18 setting forth the services it would provide to the territory if the regular annexation application was approved by the County;

WHEREAS, the City received official notification from the Trumbull County Commissioners on June 27, 2018 that the Petition for Annexation was approved by the County;

WHEREAS, 60 days has elapsed since the City received the official notification from the County pursuant to O.R.C. §709.04.

NOW, THEREFORE

BE IT RESOLVED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the annexation of the following described territory in the County of Trumbull is adjacent to and contiguous with the City of Cortland, Ohio and said annexation is acceptable to the City of Cortland, Ohio, to wit:

DESCRIPTION OF TERRITORY SOUGHT TO BE ANNEXED:

Situated in the Township of Bazetta, County of Trumbull and State of Ohio and being described as follows:

Beginning at a point being the centerline of Niles Cortland Rd. and the southern boundary line of the subject parcel, said centerline also being the boundary between the City of Cortland and the Township of Bazetta; thence N. 87° 55' W. 375 feet to a point; thence N. 2° 15' E. 85 feet to a point; thence S. 87° 55' E. 75 feet to a point, thence N. 2° 15' E. 24 feet to a point; thence S. 87° 55' E. 300 feet to a point, said point being the centerline of Niles Cortland Rd.; thence S. 2° 15' W. 109 feet to a point being the place of beginning and containing 0.8970 acres.

Section 2.
