**AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER AN AGREEMENT WITH THOMAS FOK AND ASSOCIATES, INC. TO PERFORM ENGINEERING AND BIDDING ASSISTANCE FOR THE CEDAR DRIVE WATERLINE REPLACEMENT PROJECT**

**WHEREAS**, with the passage of O-49-18 on December 3, 2018, the City submitted a loan application to the Ohio Public Works Commission for the Cedar Drive Waterline Replacement Project; and

**WHEREAS**, the project requires the performance of engineering and bidding assistance; and

**WHEREAS**, the cost of the services will be included in the loan obligation; and

**WHEREAS**, with the passage of O-37-17 on November 20, 2017, Thomas Fok and Associates, Inc. performed final preliminary detailed design to determine a schedule of quantities and a probable construction cost estimate; and

**WHEREAS**, Thomas Fok and Associates, Inc. has provided a proposal to perform design and bidding assistance.

**NOW, THEREFORE:**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:**

**Section 1.** That the Cortland City Council authorizes the Mayor to enter an agreement with Thomas Fok and Associates, Inc. 3896 Mahoning Ave. Youngstown, Ohio 44515 to perform engineering and bidding assistance for the Cedar Drive Waterline Replacement Project.

**Section 2.** That Council hereby authorizes payment for services by the Ohio Public Works Commission at a total cost not to exceed \$9,400.00 to be paid from City Fund # 5101-539-340 (Water Operating – Other Water - Professional and Technical Services).

**Section 3.** This Ordinance shall take effect and be in full force as early as allowed by law.
