**AN ORDINANCE AMENDING IN PART O-19-18 AUTHORIZING THE SERVICE DIRECTOR TO PURCHASE A JOHN DEERE 310SL BACKHOE LOADER FROM MURPHY TRACTOR & EQUIPMENT**

**WHEREAS**, there was a need to purchase a backhoe loader for use by the Cortland Service Department; and

**WHEREAS**, the Service Department researched product lines, performed price comparisons and solicited quotes and the John Deere 310SL Backhoe Loader was the preferred equipment; and

**WHEREAS**, Murphy Tractor & Equipment provided a quotation for the backhoe at a cost not to exceed \$177,845.00; and

**WHEREAS**, the equipment was eligible for a 46.7% State Contract Discount; and

**WHEREAS**, Murphy Tractor & Equipment accepted the City’s 1986 Ford 655A Backhoe Loader as a trade in the amount of \$9,000; and

**WHEREAS**, the participation in the State Cooperative Purchasing Program allowed the City of Cortland to purchase this new vehicle and equipment at the best available price; and

**WHEREAS**, the City now has the need to adjust its internal fund accounting to reflect the accurate funds for the source of this purchase.

**NOW, THEREFORE:**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:**

**Section 1.** That the Council of the City of Cortland recognized the need to purchase and did purchase a John Deere 310SL Backhoe Loader from Murphy Tractor & Equipment, 179 Perry Highway, Harmony, PA 16037.

**Section 2.** The total cost did not exceed \$85,702.46 which was paid from the following funds:
