AN ORDINANCE AUTHORIZING THE POLICE CHIEF TO PURCHASE THREE (3) POLICE TASERS AND ACCESSORIES FROM VANCE’S LAW ENFORCEMENT FOR THE POLICE DEPARTMENT AND DECLARING AN EMERGENCY

WHEREAS, there is a need for the Cortland Police Department to purchase three (3) police tasers and accessories for officers; and

WHEREAS, the Police Chief has reviewed and obtained a quote from Vance’s Law Enforcement for three (3) tasers and accessories not to exceed \$ 5,555.56; and

WHEREAS, the police tasers are an eligible purchase through Ohio’s Cooperative Purchasing Program which allows for, but does not require, the City of Cortland to purchase new equipment at the best available price through the State program; and

WHEREAS, the Police Department applied and has been awarded the Edward Byrne Memorial Justice Assistance Grant of \$5,000.00 to be used towards this purchase.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Council of the City of Cortland does hereby recognize the need for three (3) tasers and accessories from Vance’s Law Enforcement for the Police Department.

Section 2. That the Council of the City of Cortland does hereby authorize the Police Chief to purchase three (3) tasers and accessories from Vance’s Law Enforcement, 3723 Cleveland Ave, Columbus, OH 43224.

Section 3. The total cost not to exceed \$ 5,555.56 will be paid from City Fund 2901-110-270 (Police, Police Enforcement, Uniforms and Clothing).

Section 4. The Police Department has been awarded the Edward Byrne Memorial Justice Assistance Grant that will reimburse the City \$5,000.00 to be used towards this purchase.

Section 5. This Ordinance having the procedural rules suspended shall take effect immediately to guarantee a 30 day price quote at 2018 pricing as being in the best interest of the public health, safety and welfare of the residents of the City of Cortland, Ohio.
