AN ORDINANCE AUTHORIZING THE SERVICE DIRECTOR TO PURCHASE A HYDRAULIC SYSTEM, DUMP BODY, SNOW PLOW, SPREADER AND ACCESSORIES FOR THE 2019 FORD F550 4X4 PICKUP TRUCK FROM THE GLEDHILL ROAD MACHINERY CO.

WHEREAS, upon the passage of Ordinance O-20-19, City Council approved the purchase of a new 2019 Ford F550 4X4 Pickup Truck; and

WHEREAS, it is now necessary to purchase a hydraulic system, dump body, snow plow, spreader and accessories for the 2019 Ford F550 4X4 Pickup Truck; and

WHEREAS, the items are eligible through the State Purchasing Program; and

WHEREAS, the Service Department has researched product lines and approved a quote from The Gledhill Road Machinery Co. in the amount not to exceed \$40,620.00.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That the Council of the City of Cortland does hereby recognize the need for a hydraulic system, dump body, snow plow, spreader and accessories for the 2019 Ford F550 4X4 Pickup Truck.

Section 2. That the Council of the City of Cortland does hereby authorize the Service Director to purchase a hydraulic system, dump body, snow plow, spreader and accessories from The Gledhill Road Machinery Co., P.O. Box 567, Galion, OH 44833.

Section 3. The total cost not to exceed \$40,620.00 will be paid from the following City Funds:
