AN ORDINANCE AUTHORIZING THE SERVICE DIRECTOR TO ENTER INTO A CONTRACT WITH MILLER YOUNT PAVING, INC. FOR THE RESURFACING OF THE TENNIS COURTS AT WILLOW PARK AND DECLARING AN EMERGENCY

WHEREAS, the Cortland’s Parks and Recreation Board has identified the need to resurface three (3) tennis courts at Willow Park; and

WHEREAS, the Service Director solicited bids and received a quote from one (1) company; and

WHEREAS, the Service Director has reviewed and approved the proposal from Miller Yount Paving, Inc. in the amount of \$33,562.00; and

WHEREAS, the City has received \$13,000.00 in donations for the tennis court project: \$5,000.00 from Lakeview Schools, \$5,000.00 from Home Savings Bank through Lakeview Schools, \$2,000.00 from Farmers National Bank and \$1,000.00 from Cortland Rotary Club.

NOW, THEREFORE:

BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:

Section 1. That Council of the City of Cortland does hereby recognize the need to resurface the tennis courts at Willow Park.

Section 2. That Council of the City of Cortland does hereby authorize the Service Director to enter into a contract with Miller Yount Paving, Inc. 522 Perkins Jones Rd, Warren, OH 44483 to resurface three (3) tennis courts at Willow Park as specified in the quotation provided.

Section 3. The total cost of the resurfacing project shall not exceed \$33,562.00 and will be paid from the following City Funds:

\$22,044.91	1000-599-340	(General, Service Dept, Prof & Tech Services)
\$ 4,489.50	2041-320-340	(Parks & Rec, Provide and Maintain Parks, Prof & Tech Services)
\$ 7,027.59	2041-800-500	(Parks & Rec, Capital Outlay, Prof & Tech Services)

Section 4. This Ordinance having the procedural rules suspended shall take effect immediately as being necessary to expedite the project and protect the health, safety and welfare of the residents of the City of Cortland, Ohio.
