

**AN ORDINANCE AUTHORIZING THE SERVICE DIRECTOR TO ENTER INTO A CONTRACT WITH ARROW SURFACE ENTERPRISE, INC. TO PERFORM ACRYLIC COLOR COAT SURFACING AND STRIPING OF THE TENNIS COURTS AT WILLOW PARK AND DECLARING AN EMERGENCY**

**WHEREAS**, the Cortland Parks and Recreation Board has identified the need to color coat and stripe three (3) tennis courts at Willow Park; and

**WHEREAS**, the Service Director solicited bids and received quotes from three (3) companies; and

**WHEREAS**, the Service Director has reviewed and approved the proposal from Arrow Surface Enterprise, Inc. in the amount of \$16,500.00.

**NOW, THEREFORE:**

**BE IT ORDAINED BY THE COUNCIL OF THE CITY OF CORTLAND, OHIO:**

**Section 1.** That Council of the City of Cortland does hereby recognize the need to color coat and stripe the tennis courts at Willow Park.

**Section 2.** That Council of the City of Cortland does hereby authorize the Service Director to enter into a contract with Arrow Surface Enterprise, Inc ., P.O. Box 4295, Youngstown, OH 44515 to color coat and stripe three (3) tennis courts at Willow Park as specified in the quotation provided.

**Section 3.** The total cost not to exceed \$16,500.00 will be paid from City Fund 1000-599-340 (General, Other Basic Utility Service, Professional & Technical Services).

**Section 4.** This Ordinance having the procedural rules suspended shall take effect immediately as being necessary to expedite the project and protect the health, safety and welfare of the residents of the City of Cortland, Ohio.
