Situated in the Township of Bazetta, County of Trumbull and State of Ohio:

And known as being a part of Lot Number Ten (10) according to the original survey of said Bazetta Township and is bound and further described as follows:

Beginning at the centerline of Warren-Meadville Road, also known as State Route 5, being the southwest corner of the lands of Christine M. Haynam; thence North 89° 54' 00" East crossing over an iron pin at 38.48 feet distance and along the South line of said Haynam parcel a distance of 350 feet to an iron pin; thence South 20° 56' 30" West, a distance of 205.66 feet to an iron pin; thence North 84° 39' 30" West a distance of 266.84 feet to an iron pin; thence North 67° 11' 30" West and crossing over an iron pin at 85.81 feet a distance of 117.00 feet to the centerline of Warren-Meadville Road, also known as State Route 5; thence North 38° 40' 00" East a distance of 155.32 feet being the true place of beginning and containing 1.4768 acres of land with 0.1123 acres within the Right-of-Way, according to a survey made by Mathew A.
